On a motion made by Council Member Meredith, seconded by Council Member Wilson to approve the Financial Statement and paying of bills. 3 for 0 against

<u>Police</u> – Chief Jamie Walls stated Officer Sid Pendley conducted a traffic stop and two (2) arrest were made. During the stop a search of the vehicle, a pound of marijuana and various drug paraphernalia items was found. Chief Walls is in the process of seizing the vehicle.

<u>City Park Complex</u> – Mayor Love updated the council on the city park. The storage building and the fencing are down. Grass seed was placed on part of the park and is coming up. After Cherry Fest the dirt work can began on the park.

<u>The Nest Lease</u> — Mayor Love presented the lease from the city attorney for approval. Starting November 1, 2022, the rent will be \$200.00 a month and increase \$50.00 a month until the rent reaches \$450.00 a month. Rent will be due by the 5th day of the month and a \$50.00 late fee if not paid on time. All fees must be paid in full within 45 days of the due date. If the renters disagree with the rent, they have the option of the city property located at 3756 Hwy 1 for a lesser fee. If they agree with the lease the signed agreement will need to be returned by Friday, October 7, 2022, and if they disagree with the lease they can come to the council meeting on Tuesday, October 11, 2022, for further discussion with the council.

On a motion made by council member Meredith, seconded by council member DeWitt to accept the lease as presented and have it signed and retuned by October 7, 2022 or have the renters appear before the council for further discussion.. 3 for 0 against

City Building - Mayor Adam Love has been asked if the city would like to sale the building located at 101 Railroad. Mayor Love suggested to have a reserve on the building to ensure the city received fair market value for the building. The ad would need to run for 2 weeks and to the sealed bids to be opened at the November council meeting.

Accept sealed bids until noon on November 8, 2022. Sealed bids to be opened at the November meeting.
