

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF CHERRY VALLEY ARKANSAS, AND MAKING SAME A PART OF THE CITY OF CHERRY VALLEY, ASSIGNING SAME TO A WARD, AND ASSIGNING A ZONING DESIGNATION.

WHEREAS, a Petition was filed pursuant to Ark. Code Ann. § 14-40-609 for the annexation of certain territory into the City of Cherry Valley, Arkansas, and

WHEREAS, the County Assessor and the County Clerk of Cross County, Arkansas issued a Verification of Petition for Annexation Pursuant to Ark. Code Ann. § 14-40-609 verifying the Petition meets the requirements of Ark. Code Ann. § 14-40-609(b)(2) and presented the Petition and their verification to the County Judge of Cross County, Arkansas; and

WHEREAS, the County Judge has (i) reviewed the Petition and verification for completeness and accuracy, (ii) determined that no enclaves will be created by the annexation, (iii) confirmed that the Petition contains a schedule of services; and (iv) issued an order articulating these findings, authorizing annexation pursuant to Ark. Code Ann. § 14-40-609, and forwarded the Petition and order to the Mayor of the City of Cherry Valley; and

WHEREAS, the City Council of the City of Cherry Valley desires that the subject territory be annexed and become a part of the city.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHERRY VALLEY, ARKANSAS:

Section 1. That the property described on the attached Exhibit A is contiguous to the City of Cherry Valley, and that the same be and is hereby accepted as part of, and annexed to and made a part of the City of Cherry Valley, Arkansas.

Section 2. That the following schedule of services shall be extended to the area by the City of Cherry Valley within the statutorily required three (3) year period after the date the annexation becomes final, as follows: (i) police protection, and (ii) fire protection.

Section 3. That the above-described territory shall be annexed and made a part of Ward 2 of the City of Cherry Valley, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 4. That the above-described territory shall be zoned Light Industrial (I-1) to be used in accordance with the City of Cherry Valley zoning regulations and the laws of the State of Arkansas.

Section 5. Thirty (30) days after passage of this Ordinance, the annexation shall be final and the property described in this Ordinance shall be within the corporate limits of the City of Cherry Valley except as otherwise ordered by the Circuit Court of Cross County pursuant to a cause of action filed within said thirty (30) day period pursuant to Ark. Code Ann. § 14-40-609(g)(1) and (2).

Section 6. Within fifteen (15) days of the date of passage of this Ordinance the City Recorder shall provide a copy of this Ordinance and a copy of the plat map of the annexed property to the County Clerk of Cross County.
